

## Global Banishment and Expropriation Warrant issued against the Roman Catholic Church by the International Common Law Court of Justice

In accordance with the lawful order of the Court and the National Council of Common Law Assemblies of August 4, 2022,\* the Roman Catholic Church and the Vatican Incorporated, as convicted criminal organizations, are hereby and forever legally disestablished and banished from our communities. \*(<a href="https://www.murderbydecree.com">www.murderbydecree.com</a>, 'ITCCS Updates', August 4, 2022)

As required and mandated by the Court Order and International Law, the wealth, properties, lands, church buildings, and income and assets of these criminal organizations are hereby and forever expropriated by, and in the interests of, the people.

This Warrant authorizes the bearer(s) to seize and expropriate the aforenamed wealth and assets, and occupy, use, and own the aforenamed properties, lands, and church buildings.

This Warrant has universal jurisdiction and the full force and effect of the Law. The police, public, and all persons are compelled under the Law to assist in its enforcement. It is a punishable offence to interfere with the enforcement of this Warrant.

## **PUBLIC NOTICE**

It is an offense under the Law for anyone to aid, associate with, or fund the Roman Catholic Church and the Vatican. To do so is a punishable felony that can cause your prosecution for being an accessory to a criminally convicted body.
